
Nik's Notes - Mulching: News from OSU Extension

Establishment is a critical period in the life of your orchard because getting your trees off to a good start is key to ensuring your future orchard is healthy and productive. Mulching trees is a cultural practice that has a number of proven benefits for trees. When establishing hazelnut orchards, most growers mulch their bare root trees for increased soil moisture retention. Those using composts and manures are also potentially banking on gaining some fertility for their trees.

Historically, OSU has not recommended nitrogen (N) addition for bare root trees until after two growing seasons. The exception was for slow-release urea formulations, which slowly release the N similar to a compost. The slow-release is important to prevent burning of the sparse young roots. A quality bare root tree will have a good supply of nutrients from the mother tree. The goal is to get new trees into production sooner to start recouping investment in orchard establishment. Naturally, this goal can lead to an urge to push the tree as much as possible and it is not uncommon to see young trees that have been killed by fertilizer burn.

We have been evaluating several mulches in our research plots at the North Willamette Research and Extension Center. Last year was our first season evaluating the effects of mulches on tree growth (cv. "Jefferson") on our plots. From using our pressure chamber, an instrument that measures water stress of plants, we determined that trees mulched with sawdust had significantly lower water stress



compared to trees mulched with mint or municipal yard debris compost. This finding supported the hypothesis that sawdust would be better for soil moisture retention. When we looked at the effect of the mulches on tree growth, which we measure by taking caliper measurements of the trunk at the beginning and the end of the growing season, we found that trees that had compost mulch grew significantly better than trees that were grown with sawdust mulch. This was in spite of the fact that little of the compost was left on the trees by the end of the season.

One reason that tree performance with sawdust alone is low compared to compost, is that sawdust has a high ratio of carbon to nitrogen (C:N). Soil microbes immobilize N in the soil and make it unavailable to trees during the growing season because they are consuming the C-rich sawdust. The microbes become N-limited and they need the soil N for cell survival and growth. They immobilize N in the soil, which can result in a deficiency in the tree. This was apparent from 2017 trials where we fertilized some trees before we added the sawdust. Trees that received no fertilizer were visibly paler and less vigorous. The trees receiving fertilizer and sawdust together grew better than sawdust mulch alone, compost mulch, or un-mulched trees did. There was also a corresponding increase in foliar N in the trees that were fertilized and mulched with sawdust (see Figure). To summarize, sawdust mulch has some great qualities (some not discussed) as a mulch including high soil moisture retention, high persistence and low cost. Our results suggest sawdust is best used in combination with a low rate of slow-release fertilizer. Composts can give excellent tree growth in the first year but they broke down rapidly in our plots and would require reapplication if used as a source of fertility for organic production.
